

Fees for Arbitration & Appeal under By-law 38

- (a) Registration Fee: (To be paid in advance by the claimant and by respondent in case respondent files a counter claim) :

i) For Members	5,500/-
ii) For Non-members	11,000/-

Registration fee is non-refundable and becomes the property of the Association. GST at applicable rate is payable over and above the registration fee.

- iii) GST at applicable rate is payable over and above the administrative fee.

- (ii) If application for arbitration and counter claim by respondent is rejected before commencement of arbitration proceeding, Arbitration fees deposited by claimants and by respondent, if any, will be refunded. However Registration fees are not refundable.
- (iii) GST at applicable rate is payable over and above the arbitration fee.
- (d) Special Charges incurred by the Arbitrator/s in relation to arbitration at actual.
- (e) Adjournment Fees for Arbitration Hearing
- @Adjournment fee: Rs.16,500/- per adjournment plus GST at applicable rate to be paid to CAI by party(ies) requesting for adjournment- Non-refundable.
- As far as possible Plaintiffs & Defendants may be allowed minimum adjournments subject to payment of adjournment fees.
- (f) Hiring of Room Charges for arbitration hearings in other than CAI Premises (at actual – To be paid by both parties equally)
- (g) Stenographer charges (at actual - To be paid by both parties equally)
